It is recommended that customers apply all subsequent Release Packs immediately following Rx Packs. Doing so will benefit both customers and Infinite Campus when it comes to supporting the patch.

Rx Packs are cumulative; each Rx pack will automatically include all previous Rx packs within that release. These cases will also be included in the Campus.2120 pack unless otherwise noted.

#### Upgrade to Taglibs Causing Issues with Previous Version Production App (SIS-146473)

A taglibs update in Campus.2116 is causing an issue where if a district is running Campus.2116 in a staging environment on the same Tomcat instance as their production app which is running an

earlier version of Campus, certain changes will affect both app versions causing problems with the older production app. This issue was corrected.

The OPE ID field was added in the Campus.2112 Release Pack (March 2120) and reports on the SMART Student Course Data Extract.
