It is recommended that customers apply all subsequent Release Packs immediately following Rx Packs. Doing so will benefit both customers and Infinite Campus when it comes to supporting the patch.

Rx Packs are cumulative; each Rx pack will automatically include all previous Rx packs within that release. These cases will also be included in the Campus.2124 pack unless otherwise noted.

After taking the Campus.2120 Release, users reported not being able to save local student numbers. This has been corrected.

As part of this correction, the following issues have also been addressed:

- Special characters are now allowed in the User Group Name, User Name and Student Number. Approved special characters are: ~, ` , !, @, #, \$, %, ^, &, \*, ( ), -, \_ , +, =, { }, [ ], |, \, ' , < > , / , ? , " , ' , ; , ;
- Large values (up to 15 characters) can now be entered for a Student Number.
- The ability to generate Student numbers for new and existing students through the Student Locator now functions correctly.

corrected that users only need to be an active member to view an IEP via the Roster.

enrollment where the Resident District does not match the site district.

The overlapping enrollment end date logic in the Student Program Associations resource has been updated to only look at enrollments with a Local Service Type of 'P:Primary'. The enrollment logic has also been updated so enrollments with a Local Service Type other than 'P:Primary' only report if they are the only enrollment in a given time frame. Other local service types do not report if they overlap with any other enrollment from the same school or any other school.

A resync on the Student Program Associations resource needs to be completed with this update.

## Localization - Kansas

Kansas - KIDS EOYA, ENRL Updates (SIS-146973)

The following updates have been made to the **KIDS EOYA Extract**:

- Dyslexia Screener (field 60), Dyslexia Subtest (field 61) and Dyslexia Spring Benchmark Performance Level (field 62) only report when the student is in grades 05, 06, or 07. If the student is in grades 05, 06, or 07, and there is no Dyslexia result for these fields, a value of 00 reports.

- Individual Plan of Student (field 90) only reports a value when the student is in grades 11-17.

The following updates have been made to the \*KIDS ENRL and EOYA Extracts\*:

- Kansas Preschool Program (field 58) reports a value of 0 when the student is in grades 01, 02, 33, & 04 and there is not an Early Learning record or the Early Learning Participant (KS PreK Pilot Program) checkbox is not marked.
- Kansas Parents as Teachers (field 59) reports a value of 0 when the student is in grades 00, 01, 02, 33, & 04 and there is not an Early Learning record or the Parents as Teachers checkbox is not marked.
