Users with read-only rights to Activity Dashboard were allowed to modify data on the Roster screen and export those modifications to Excel even though the changes weren't saved and couldn't be saved by the user. The issue was corrected.

Improvement

The roster screen now has a "Save and Stay" option which allows users who are making multiple changes to save their changes without having to re-open the roster screen.

Other enhancements have been made to the report, as follows:

- Text announcing what the report does and how to use it has been updated.
- Student Day Minutes are now included in the Report Header when generating in PDF or DOCX format. This value is determined by the Student Day Minutes entered on the Calendar Information tool.
- The Absence Code column has been renamed to ATT Code.
- The Absence Mark column has been renamed to Count.
- The Minutes column now displays before the Days column in all formats.

A SIF event trigger has been added on Enrollments for when an enrollment is marked State Excluded or No Show, even when the SIF Zone Options are set to exclude No Show and/or State Excluded enrollments.

- On an enrollment record save:
 - StudentPersonal:
 - When there is no non-excluded enrollment for the student in Campus (in the Zone Year selected), provide a Delete event
 - When the student is now provided with a non-excluded enrollment for the student in Campus (in the Zone Year selected), provide an Add event.
 - StudentSchoolEnrollment:
