Field	Description
<b>State Exclude</b>	Excludes the enrollment record from reporting on all state reporting extracts that honor state exclude functionality. Students marked as State Exclude are not included in any state reports.
<b>FTE</b>	This field is used to determine Maryland's attendance calculations for State Reporting.
<b>Immunization Compliance</b>	This checkbox is used to help determine the State Aid Eligibility calculated value on the September 30th extract.
<b>State Aid Eligibility</b>	<p>This field is calculated by the <a href="#">State Aid Eligibility</a> tool, but can also be overwritten by a user with tool rights.</p> <p><b>Options</b></p> <ul style="list-style-type: none"> <li>• 00: Withdrawn</li> <li>• 01: Eligible for state aid</li> <li>• 02: Ineligible - age 21 and over</li> <li>• 03: Ineligible - age less than 5</li> <li>• 04: Ineligible - no attendance in September</li> <li>• 05: Ineligible - Maryland non - resident student</li> <li>• 06: Ineligible - COMAR 13A.02.06</li> <li>• 07: Ineligible - documentation of immunization unavailable</li> <li>• 08: Ineligible - documentation of sustained effort or residency unavailable</li> <li>• 09: Ineligible - Nonpublic Placement</li> </ul>
<b>Migrant</b>	Indicates whether the student has migrant status.
<b>Foreign Exchange</b>	Indicates whether the student is a foreign exchange student.
<b>Opt Out</b>	Indicates whether legal guardian has chosen to opt-out of the release of directory information.
<b>Gifted/Talented</b>	Indicates whether the student is identified as gifted/talented.
<b>Non Resident</b>	Indicates whether the student is a resident.
<b>Homeless</b>	Indicates whether the student is homeless.
<b>Homeless Unaccompanied Youth</b>	Indicates the student is not in the presence of a parent, guardian or legal status identified by the court system.
<b>Primary Nighttime Residence</b>	<p>Indicates the nighttime residence of the homeless student.</p> <p><b>Options</b></p> <ul style="list-style-type: none"> <li>• D: Doubled-up</li> <li>• M: Motels/Hotels</li> <li>• S: Shelters, Transitional Housing, Awaiting Foster Care</li> <li>• U: Unsheltered</li> </ul>

Field	Description
<b>Homeless Served McKinney</b>	Indicates whether the student receives McKinney-Vento funds.
<b>Homeless Served Other</b>	Indicates whether the student is served with funds other than McKinney-Vento.
<b>Home School</b>	Identifies the home/responsible school for a special education student.
<b>Home Schooled</b>	Indicates whether the student is home schooled.
<b>Proof of Residence</b>	Used for MD Student Records Cards.
<b>Single Parent</b>	Indicates whether the student is a single parent. Used in CTE reporting.
<b>Military Connected Status</b>	Used to provide district with detailed information about the student's parent's military connected status.
<b>Predominant/Prior/Home Care</b>	<p>Indicates the predominant, Prior, Home Care for PK students.</p> <p><b>Options</b></p> <ul style="list-style-type: none"> <li>• 1: Head Start</li> <li>• 2: Prekindergarten</li> <li>• 3: Child Care Center</li> <li>• 4: Family Child Care</li> <li>• 5: Non-Public Nursery School</li> <li>• 6: Repeated Kindergarten</li> <li>• 7: Home Care</li> </ul>
