Health vaccines and their associated compliance listings are based on state guidelines. The following information describes vaccine compliance rules as defined by the Montana Department of Health.

## General Compliance

- Half-doses or reduced doses of a vaccine are not considered valid.
- 4 day tolerance periods should be given for all spacing requirements.

## DTaP

Rule	Requirements
<b>3 Doses - Complaint - Age 7 and older</b>	<ul style="list-style-type: none"> <li>• First does on or after 1 year of age</li> <li>• At least 1 dose of Td/Tdap on or after age 7</li> </ul>
<b>4 Doses - Compliant - Pre-Kindergarten</b>	<ul style="list-style-type: none"> <li>• Must be in a State Grade level of PK</li> </ul>
<b>4 Doses - Compliant</b>	<ul style="list-style-type: none"> <li>• 4th dose on or after age 4</li> <li>• Difference between dose 4 and birth date is less than or equal to 7 years</li> </ul>
<b>4 Doses - Compliant - Age 7 and older</b>	<ul style="list-style-type: none"> <li>• At least one dose of Td/Tdap on or after age 7</li> </ul>

## Tdap

Rule	Requirements
<b>PK to 6th</b> <i>No Requirement</i>	Students in state grades: 01, 02, 03, 04, 05, 06, KF, KH, P1, PK are not required to receive any doses of the Tdap vaccine.
<b>1 dose grades 7-12</b> <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> <li>the student is in state grade: 07, 08, 09, 10, 11, 12,</li> <li>the student receives 1 dose of the Tdap vaccine, and</li> <li>the difference between the last dose and the student's birthdate is greater than or equal to 84 months with a 4 day tolerance.</li> </ul>
<b>Default</b>	Non-compliant

## MMR

Rule	Requirements
<b>1 Dose - Compliant - Pre-Kindergarten</b>	<ul style="list-style-type: none"> <li>First dose on or after 12 months of age</li> </ul>
<b>2 Doses - Compliant</b>	<ul style="list-style-type: none"> <li>2 Measles, Mumps and Rubella OR</li> <li>2 Measles, 2 Mumps, 2 Rubella OR</li> <li>1 Measles, Mumps, Rubella and 1 Measles, 1 Mumps, 1 Rubella</li> <li>1st dose on or after 12 months of age</li> <li>Difference between dose 2 and previous is at least 1 month</li> </ul>

## Polio

No requirement for students 18 years of age and older.

Rule	Requirements
<b>3 Doses - Compliant - Pre-Kindergarten</b>	<ul style="list-style-type: none"> <li>No requirements</li> </ul>
<b>3 Doses - Compliant</b>	<ul style="list-style-type: none"> <li>Dose 3 on or after 4th birthday</li> <li>Difference between dose 3 and previous is at least 28 days</li> <li>Difference between dose 2 and previous is at least 28 days</li> </ul>

# Hib

No requirement for students age 60 months and older.

No requirements for students in grades K-12.

Rule	Requirements
<b>1 Dose - Compliant - Pre-Kindergarten</b>	<ul style="list-style-type: none"> <li>1st dose on or after 12 months of age</li> </ul>

# Varicella

No requirement for students 0 to 11 months.

Default of non compliant.

Rule	Requirements
<b>1 Dose - Compliant - Pre-Kindergarten</b>	<ul style="list-style-type: none"> <li>Minimum age 12 months</li> <li>Dose on or after 1st birthday</li> </ul>
<b>2 Doses - Compliant - PK-12th Grade</b>	<ul style="list-style-type: none"> <li>Minimum age 12 months</li> <li>First dose on or after 1st birthday</li> <li>Space between dose 1 and dose 2 must be equal to or greater than 28 days.</li> </ul>
