

# Arizona Ed-Fi Data v3.5 - Discipline Actions

This event entity represents actions taken by an education organization after a disruptive event that is recorded as a discipline incident.

## **Object Triggering**

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	<ul> <li>Reports when a Behavior Resolution is added to an incident that is marked as Complete and is aligned to a reported Behavior Event.</li> <li>Incident must have at least 1 behavior event associated and the event is mapped to an Ed-Fi Value.</li> <li>Incident must be tied to a Behavior Incident that has at least one Behavior Resolution that is mapped to an Ed-Fi Value.</li> <li>Student must be in SPED on the date of the reported behavior event that is identified by: <ol> <li>Student has a locked IEP that overlaps the dates of the reported behavior event.</li> <li>Student has NO IEPs and has a flag with a state code of '999' (IEP) that overlaps the dates of the reported behavior event.</li> <li>Posting can occur if a new event is added after Incident is marked as "Complete".</li> <li>Do not send if the student's grade is marked as State Exclude.</li> <li>Do not send if the student is in a calendar marked as Exclude.</li> </ol> </li> </ul>
Put	<ul><li>When data that is not part of the Natural Key is changed.</li><li>When Resolution End Date is changed.</li><li>When Duration in School Days is changed.</li></ul>
Delete/Post	<ul><li>When data that is part of the Natural Key is changed.</li><li>If the resolution date is changed do a delete and post.</li></ul>
Delete/Post	<ul> <li>When the Incident's status is changed.</li> <li>Delete when the status is changed from Completed to In Progress.</li> <li>Post when the status is changed from In Progress to Completed.</li> </ul>
Delete/Post	<ul> <li>When a student's SPED IEP is changed.</li> <li>Delete when the IEP is unlocked.</li> <li>Post when the IEP is locked.</li> <li>Delete if the IEP dates are updated to no longer overlap the behavior incident.</li> <li>Post if the IEP dates are updated to now overlap the behavior incident.</li> </ul>



Action	Trigger
Delete/Post	<ul> <li>When student's flag with a state code of 999 (IEP) is changed.</li> <li>Delete if flag dates are updated to no longer overlap the behavior incident.</li> <li>Post if flag dates are updated to now overlap the behavior incident.</li> <li>Delete when a flag with dates that overlaps the behavior incident is deleted.</li> <li>Post when the flag with dates that overlap the behavior incident has the program updated to 999 (IEP) or new flag is added with a program state code of 999 (IEP).</li> </ul>
Delete	When a resolution is deleted.
Delete	When all resolutions are removed from the incident.
Delete	When all Behavior Events are removed from the incident.
Delete	When an incident is deleted.
Delete	When the associated student enrollment is deleted.
Delete	When the student's Role changes to anything other than Offender.
Delete	When all non-excluded enrollments in the school and year are deleted.
Delete	When all Student Discipline Incident Associations and all Student Discipline Incident Behavior Associations are deleted that are associated with this Disciple Incident record.

## **Resource Toggle/Resync**

Action	Business Rule
None	If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed- Fi Identity Mapping table
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.

## Natural Key Changes/Cascading Updates, Deletes

Action	Business Rule
Post/Delete	<ul> <li>Natural Key changes:</li> <li>If an Ed-Fi ID changes, this will happen with the cascading deletes from the Ed-Fi ID Change trigger.</li> <li>If the Discipline Date changes.</li> </ul>

### **Scope Year**

#### **Business Rules**

Discipline records will only send to the school year they are aligned to.



Data will only send for the years that have valid configuration.
