Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Massachusetts State Department of Health.

General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days before the minimum interval or age are not considered valid and must be repeated as age-appropriate.

Meningococcal

Rule	Requirements
1 dose 20-21 <i>Compliant</i> <i>Active End Date:</i> <i>06/30/2021</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> • the student is in state grade: 07, and • the student receives one dose of the Meningococcal vaccine.
1 dose 21-22 <i>Compliant</i> <i>Active Start date:</i> <i>07/1/2021</i> <i>Active End date:</i> <i>06/30/2022</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> • the student is in state grade: 07, 08, and • the student receives one dose of the Meningococcal vaccine.

Rule	Requirements
<p>1 dose 22-23 Compliant Active Start Date: 07/1/2022 Active End Date: 06/30/2023</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, and the student receives one dose of the Meningococcal vaccine.
<p>1 dose 23-24 Compliant Active State Date: 07/1/2024</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, 10, and the student receives one dose of the Meningococcal vaccine.
<p>2 dose 20-21 Compliant Active End Date: 06/30/2021</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 11, the student receives two dose of the Meningococcal vaccine, and the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.
<p>2 dose 21-22 & beyond Compliant Active Start Date: 7/1/2021</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 11, 12, the student receives two dose of the Meningococcal vaccine, and the difference between the second and previous dose is greater than 56 days with a 4 day tolerance.
<p>1 dose at 16 Compliant</p>	<p>Students are considered compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student receives one dose of the Meningococcal vaccine, and the difference between the last dose and the birthdate is greater than 192 months with a 4 day tolerance.
<p>No dose 20-21 Non-Compliant Active End Date: 6/30/2021</p>	<p>Students are considered non-compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 07, 11, and the student has not received any doses of the Meningococcal vaccine.
<p>No dose 21-22 Non-Compliant Active Start Date: 7/1/2021 Active End Date: 6/30/2022</p>	<p>Students are considered non-compliant if the following conditions have been met:</p> <ul style="list-style-type: none"> the student is in state grade: 07, 08, 11, 12, and the student has not received any doses of the Meningococcal vaccine.

Rule	Requirements
No dose 22-23 <i>Non-Compliant</i> <i>Active Start Date:</i> <i>7/1/2022</i> <i>Active End Date:</i> <i>6/30/2023</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, 11, 12, and the student has not received any doses of the Meningococcal vaccine.
No dose 23-24 & beyond <i>Non-Compliant</i> <i>Active Start Date:</i> <i>7/1/2023</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade: 07, 08, 09, 10, 11, 12, and the student has not received any doses of the Meningococcal vaccine.

DTaP

Grade	Requirements
PK	4 doses required
K	5 doses required - combined doses of Diphtheria-tetanus-pertussis (DTaP, DTP)
K-12	4 doses required - The difference between the last dose and birth date must be greater than or equal to 4 years.
1-12	3 doses of Td or Tdap

Tdap

Rule	Requirements
1 dose Grades 7-12 <i>Compliant</i>	Students are considered compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade(s): 07, 08, 09, 10, 11, 12, the student receives one dose of the Td or Tdap vaccine, and the difference between the dose and the student's birthdate is greater than 84 months with a 4 day tolerance.
Grades 7-12 Default <i>Non-compliant</i>	Students are considered non-compliant if the following conditions have been met: <ul style="list-style-type: none"> the student is in state grade(s): 07, 08, 09, 10, 11, 12, and the student has not received any doses of the Td or Tdap vaccine.

Hepatitis B

Students must have received **3 doses** of Hepatitis B to be considered compliant. The default

setting is non-compliant.

MMR

Grade	Dose	End Date
PK	1 dose of MMR or M, M and R	
K-12	2MMR or 1MMR, 1M, 1M and 1R or 2M, 2M and 2R	

Varicella

Grade	Dose
PK	1 dose
Any	2 doses

Polio

Doses	Requirements
3 doses required	Grade = PK
4 doses required	Grade = Any
3 doses required	All OPV with the last dose received on or after the 4th birthday.
3 doses required	All IPV with the last dose received on or after the 4th birthday.

Hib

Grade	Requirement
PK	1 dose
PK	Default setting is Non-Compliant
Any other	Default setting is No Requirement
