## Primary Digital Device

List the type of device the student uses to access the internet in the residence.

- DL: Desktop/Laptop
- TA: Table
- CB: Chromebook
- SP: SmartPhone
- NA: None
- OT: Other

Indicates the owner of the device.

- P: Personal
- S: School
- O: Other

## Internet Access in Residence
