

# Nebraska Ed-Fi Data v3.5 - Discipline Actions

This event entity represents actions taken by an education organization after a disruptive event that is recorded as a discipline incident.

## Object Triggering Logic

This table describes logic for triggering syncing of this object.

Action	Trigger
Post	<p>Reports when a Behavior Resolution is added to an incident that is marked as Complete and saved.</p> <ul style="list-style-type: none"> <li>• Only report behavior resolutions that have state code with an Ed-Fi Code value and are aligned to a reported Student Discipline Incident Association record.</li> <li>• Do not send if the student is in a School marked as Exclude.</li> <li>• Do not send if the student's enrollment is marked as No Show or State Exclude.</li> <li>• Do not send if the student is in a calendar marked as Exclude.</li> </ul>
Delete/Post	<p>When data that is part of the Natural Key is changed.</p> <ul style="list-style-type: none"> <li>• If the resolution date is changed do a delete and post.</li> </ul>
Delete/Post	<p>When the Incident's status is changed.</p> <ul style="list-style-type: none"> <li>• Delete when the status is changed from Completed to In Progress.</li> <li>• Post when the status is changed from In Progress to Completed.</li> </ul>
Put	<p>When a state mapped discipline is added or removed and there are other state mapped resolutions on the incident.</p>
Delete	<p>When a resolution is deleted.</p>
Delete	<p>When all resolutions mapped to a State Resolution code with an Ed-Fi Code are removed from the incident.</p>
Delete	<p>When all Behavior Events that are mapped to a State Code with an Ed-Fi value are removed from the Incident.</p>
Delete	<p>If the state mapping on the event is changed to NULL or Not State Reported and no other state mapped event exists on the incident.</p>
Delete	<p>When all non-excluded enrollments in the school and year are deleted.</p>

## School Exclude, Calendar Exclude, Resource Toggle and Resync Logic

This table describes the School Exclude, Calendar Exclude, Resource Toggle and Resync logic of this object.

Action	Trigger
None	<p>If a resource is toggled to 'OFF' after data has sent, all sent data will remain in the ODS but no new data will send.</p>

Action	Trigger
Resync	If a record is in the Ed-Fi Identity Mapping table and not in the ODS, it will be deleted from the Ed-Fi Identity Mapping table.
Resync	If a record is in the ODS and it does not have a matching record in Campus or the Ed-Fi Identity Mapping table, it will be deleted from the ODS.
Resync	If a mapping is changed in Resource Preferences, a resync will need to be done to reflect the changes.

## Natural Key Changes, Cascading Updates, and Deletes Logic

This table describes the Natural Key Changes/Cascading Updates and Deletes logic of this object.

Action	Trigger
Post/Delete	Natural Key changes: <ul style="list-style-type: none"> <li>If an Ed-Fi ID changes, this will happen with the cascading deletes from the Ed-Fi ID Change trigger.</li> <li>If the Discipline Date changes.</li> </ul>

## Scope Year Logic

Logic
Discipline records will only send to the school year they are aligned to.
Data will only send for the years that have valid configuration.
