

# **Report Logic**

The Student Template reports records for all students enrolled in the selected calendar(s) between the Start Date and and the Effective Date entered during report generation.

All Enrollment Service Types (Primary, Partial, Special Education) are reported.

# **Report Editor**

Field	Description
Extract Type	Determines the type of PIMS Extract being generated.
Start Date	The entered date is used to return all enrolled students between this date and the Effective Date.
Effective Date	Entered date is used to return all students enrolled between the Prior Reporting Date and this date.
Format	Determines how the extract generates. Extracts can be generated in State Format (comma delimited) or HTML. Use the HTML format for reviewing and verifying data prior to submission to the state.  Use the State Format for submitting the data to the Department of Education.
Report Protected Identities	When marked, last name, first name, middle name, suffix, and gender information reports from the Protected Identity Information section on the Identities editor, if the fields are populated.
Report All Addresses  When marked, address fields included in the report (Address Addresses 2, City, State, Zip) report for each student record.  marked, address information only reports for Special Education CTE students only.	
<b>Enrollment Detail</b>	When marked, every enrollment for students within the entered report date range reports.
Ad hoc Filter	Select an existing ad hoc filter from which to report students. Only those students included in the <b>Student</b> Data Type filter and who meet the reporting population are included in the extract.
Select Grades	Select which grade levels to include on the report.
Calendars	At least one calendar must be selected when generating a PIMS extract. Calendars can be selected by the Active Year, by School or by Year. If a calendar is chosen in the Campus toolbar, that calendar is automatically be selected.



Field	Description
Report Generation	To generate the report immediately, use the <b>Generate Extract</b> option. To choose when the report generates, use the <b>Submit to Batch</b> option. Submit to Batch is useful when generating the report for several calendars or for larger amounts of data being reported. See the Batch Queue article for more information.

### **Generate the Student Template**

- 1. Select **Student Template** from the **Extract Type** from the dropdown list.
- 2. Enter the **Start Date** of the extract in *mmddyy* format or use the calendar icon to select a date.
- 3. Enter the **Effective Date** of the extract in *mmddyy* format or use the calendar icon to select a date.
- 4. Select the **Format** of the extract.
- 5. If desired, mark the **Report Protected Identities** checkbox.
- 6. If desired, mark the **Report All Addresses** checkbox.
- 7. If desired, mark the **Enrollment Detail** checkbox.
- 8. If desired, select an Ad hoc Filter.
- 9. Select a **Grade** level for the extract.
- 10. Select the appropriate Calendar(s) from which to include data on the extract.
- 11. Click the **Generate Extract** button or the **Submit to Batch** button, if available. The extract displays in the selected format.
