In order to be included in the report, students must have a behavior resolution with a State Code of one of the following:

- S5: Expulsion less than one calendar year
- S6: Expulsion one calendar year
- S7: Expulsion more than one calendar year

Students must have a Special Ed Status of Y: Yes on or after the behavior incident date.

Students must be enrolled in one of the following state grade levels:

Row 2: Count of Children without Disabilities, Grades K-12

Students do not have a Special Ed Status of N: No IEP or E: Exited on or after incident date.

Report Editor

Field	Description
Extract Type	Determines the type of Extract being generated. For this extract, select Table 13 Extract.
Format	Determines how the extract generates. Extracts can be generated in State Format (comma delimited) or HTML. Use the HTML format for reviewing and verifying data prior to submission to the state. Use the State Format for submitting the data to the Department of Education.
Report Generation	To generate the report immediately, use the Generate Extract option. To choose when the report generates, use the Submit to Batch option.
