Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Rhode Island Department of Health.

#### **General Compliance**

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are considered valid.
- Doses administered 5 days earlier than the minimum interval or age are not considered valid doses and must be repeated as age-appropriate.

<b>0-2</b> <b>months</b> <i>No</i> <i>requirement</i>	Students age 0-2 months old are not required to receive any doses of the DT, Tdap, Td, or DTaP-DTP vaccine.
<b>3-4</b> <b>months</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 3 months, but no older than 4 months old, and</li> <li>the student receives one dose of the DT, Tdap, Td, or DTaP-DTP vaccine.</li> </ul>
<b>5-6</b> <b>months</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 5 months, but no older than 6 months old, and</li> <li>the student receives two doses of the DT, Tdap, Td, or DTaP-DTP vaccine.</li> </ul>
<b>7-18</b> months Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 7 months, but no older than 18 months old, and</li> <li>the student receives three doses of the DT, Tdap, Td, or DTaP-DTP vaccine.</li> </ul>

<b>4th dose</b> <b>after 4yrs</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student receives four doses of the DT, Tdap, Td, or DTaP-DTP vaccine,</li> <li>the difference between the first dose and the student's birthdate is less than 42 days with a 4 day tolerance,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth dose and the previous is greater than 48 months with a 4 day tolerance.</li> </ul>
<b>4th dose 7</b> <b>yrs or</b> <b>older</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 84 months old,</li> <li>the student is in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12,</li> <li>the student receives four doses of the DT, Tdap, Td, or DTaP-DTP vaccine,</li> <li>the difference between the first dose and the student's birthdate is less than 11 months with a 4 day tolerance,</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance,</li> <li>the difference between the fourth dose and the previous is greater than 6 months with a 4 day tolerance, and</li> <li>the difference between the fourth dose and the student's birthdate is greater than 48 months with a 4 day tolerance.</li> </ul>

<b>Default K- 12</b> <i>Non-</i> <i>compliant</i>	Students in state grade KF: KG Full Day, KG: KG 1/2 Day, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12 who have not received any doses of the DT, Tdap, Td, or DTaP-DTP vaccine are considered non-compliant.

# Tdap

Rule	Requirements
<b>1 dose</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>student is in state grade 07, 08, 09, 10, 11, 12, and</li> <li>the student receives 1 dose of the Tdap vaccine.</li> </ul>
No Doses Non- compliant	Students in state grade 07, 08, 09, 10, 11, 12, who have not received any doses of the Tdap vaccine are non-compliant.

# Hepatitis **B**

Rule	Requirements
<b>0-2 Months</b> <i>No Requirement</i>	Students age 0-2 months old are not required to receive any doses of the Hepatitis B vaccine.

<b>3-4 Months</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 3 months, but no older than 4 months old, and</li> <li>the student receives one dose of the Hepatitis B vaccine.</li> </ul>
<b>5-18 Months</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 5 months, but no older than 18 months old, and</li> <li>the student receives two doses of the Hepatitis B vaccine.</li> </ul>
<b>19 months and older</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 19 months old, and</li> <li>the student receives three doses of the Hepatitis B vaccine.</li> </ul>

# Polio

<b>19 months</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 19 months old, and</li> <li>the student receives three doses of the IPV, OPV, or IPV-OPV Polio vaccine.</li> </ul>
<b>18 yrs and</b> older No Requirement	Students age 216 months (18 years) old and older are not required to receive any doses of the IPV, OPV, or IPV-OPV Polio vaccine.

<b>3-4 months</b> <i>Compliant</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 3 months, but no older than 4 months old, and</li> <li>the student receives one dose of the Pneumococcal (PPV) vaccine.</li> </ul>

5-6 months	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is at least 5 months, but no older than 6 months old, and</li> <li>the student receives two doses of the Pneumococcal (PPV) vaccine.</li> </ul>

<b>3 doses</b> <i>Compliant</i> <i>Active Start</i> <i>Date: 8/1/17</i>	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: 09,</li> <li>the student receives three doses of the Human Papillomavirus (HPV) vaccine,</li> <li>the difference between the third dose and the second valid dose is greater than 84 days with a 4 day tolerance, and</li> <li>the difference between the third dose and the first valid dose is greater than 168 days with a 4 day tolerance.</li> </ul>

2 dose 12th Grade Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: 12,</li> <li>the student receives two doses of the Meningococcal (MCV4) vaccine,</li> <li>the difference between the second dose and the student's bithdate is greater than 192 months with a 4 day tolerance, and</li> <li>the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.</li> </ul>
1 dose 12th Grade Compliant	<ul> <li>Students are considered compliant if the following conditions have been met:</li> <li>the student is in state grade: 12,</li> <li>the student receives one dose of the Meningococcal (MCV4) vaccine, and</li> <li>the difference between the first dose and the student's bithdate is greater than 192 months with a 4 day tolerance.</li> </ul>
