Search Terms: P-EBT Upload

The P-EBT (Pandemic Electronic Benefits) Extract returns a count of a student's P-EBT eligible days for a month during the reporting range for those students who receive free or reduced meals.

WI P-EBT Upload

The WI P-EBT Upload will return the number of P-EBT Eligible days a student qualifies for each month. Eligible students must be actively receiving free/reduced price meals or enrolled in a CEP school. P-EBT Eligible Days are dates on which an eligible student was learning virtually or absent for a COVID-related reason. Learning Virtually and COVID-related absences will need to be documented in the P-EBT Instruction Mode state program to be pulled into this report for districts not using Blended Learning or if a student has a P-EBT eligible day on a date where their Blended Learning Group is having In-Person instruction. P-EBT data will only calculate days through the final completed month prior to the Effective Date. The P-EBT Upload is available in the state-required CSV format for submission as well as a human readable HTML format for troubleshooting.

P-EBT Upload

Report Logic

A student must have an active primary enrollment and be receiving free or reduced price meals in the selected school during the reporting range - August 1 through the entered Effective Date.

Students are counted when they have an active Free or or Reduced [FRAM eligibility](#) or when a

school is enrolled in the USDA Community Eligibility Provision (CEP) School.

- The [School History](#) record must have a Provision of 5: CEP.
- The School Year being reported must be within the Provision Base Year and the Provision End Year.

A P-EBT Eligible day is one in which a student who received free/reduced meals is learning virtually or is absent for a COVID-related reason.

- P-EBT eligible days are calculated for whole months with the date range that is in the past. When the entered effective date is March 15, P-EBT eligible days are calculated through February.
- When a student does not have any P-EBT eligible days, they are not included in the report.

A student must also have an [Instruction Mode](#) record where they are learning virtually or were absent from on-site learning due to COVID, OR they are in a [Blended Learning Group](#) that is meeting virtually for the day.

Students are not included when:

- The enrollment record is marked as No Show, WISE Exclude or State Exclude.
- The grade level of enrollment is marked as State Exclude.
- The calendar of enrollment is marked as State Exclude or Summer School.

Report Editor

Field	Description
Effective Date	Entered date is used to count a student's P-EBT eligible days, starting from August 1. The current date is auto-populated; use the calendar icon to select a new date, or enter a new date in mm/dd/yyyy format.
Grade	Selection indicates which grade levels of enrollment are included in the report.
Ad hoc Filter	Select a saved ad hoc filter to only include those students in the filter in the report, assuming those students meet the reporting logic and business rules of this report.
Format	The P-EBT Extract can be generated in either CSV or HTML formats.
Calendar Selection	At least one calendar needs to be selected in order to generate the report. Reports can be selected by Active Year, School or Year.
Report Generation	The P-EBT Extract can be generated immediately using the Generate Report button. Or, use the Submit to Batch button to select when the report is generated. See the Batch Queue article for more information on this functionality.

Generate the P-EBT Extract

1. Enter the desired **Effective Date**.
2. Select the desired **Grade** levels to include in the report.
3. If desired, select students from an existing **Ad hoc Filter**.
4. Select the **Format** of the report.
5. Select the **Calendar(s)** from which to report information.
6. Click the **Generate Extract** button or use the **Submit to Batch** button. The report displays in the desired format.
