- Calendars marked as Exclude are not listed on the editor. Excluded calendars are not reported.

# Report Editor

The following table describes the fields available on the CO Immunization Summary editor:

| Field                                  | Description  |
|--|--|
| <b>Grade</b>                           | The grade level of students you would like to include on the report.   |
| <b>Ad Hoc Filter</b>                   | An optional ad hoc filter can be selected from the dropdown to further narrow results on the report.   |
| <b>All school compliance totals</b>    | Indicates that all school compliance totals should be included on the report.  |
| <b>McKinney-Vento totals</b>           | Indicates that the McKinney-Vento column should be included on the report.   |
| <b>Summary Totals</b>                  | Indicates that the student summary totals should be included on the report.  |
| <b>Compliance Percentages included</b> | Indicates that the compliance percentage totals should be included on the report.  |
| <b>Grade level breakdown</b>           | Indicates if the report should be broken down by grade level. If unmarked, only vaccine totals will display.   |
| <b>Calendar Selection</b>              | Which calendar(s) will be included on the report.  |
| <b>Choose Vaccines</b>                 | Which vaccines will be included on the report. The Toggle Vaccines option will mark or unmark all vaccines.  |
| <b>Generate Extract</b>                | Generates the report in a PDF format.  |
| <b>Submit to Batch</b>                 | <p>An option that allows the report to generate in the background.</p> <p>This is a very complex report. Limit the number of students run per batch or select <b>Submit to Batch</b> to generate the report in the background while you use other areas of Campus. See the <a href="#">Batch Queue</a> article for additional information.</p> |

# Generation Steps

1. Select which **Grade Level(s)** you would like to include on the report.
2. Optional: Choose an **Ad Hoc filter** from the dropdown.
3. Select which **Calendar(s)** you would like to include in the report.
4. Choose which **Options** you would like to include in the report. Options include:
  - All schools compliance totals
  - McKinney-Vento totals
  - Summary totals
  - Compliance Percentages included
  - Grade level breakdown
5. Select which **Vaccines** you would like to include on the report by marking or unmarking the checkboxes.
6. Click **Generate Extract** or **Submit to Batch** to generate the report. The report generates in a PDF format.

# Report Layout

| Name               | Description  |
|--------------------|--|
| <b>State Grade</b> | Displays each grade level in a new row selected when generating the report.  |
| <b>Compliant</b>   | Indicates the total number of students in a grade level that are compliant or have no requirements for all vaccines. |

| Name                             | Description  |
|----------------------------------|--|
| <b>One of more exemption</b>     | Indicates the total number of students who have at least one vaccine exemption.  |
| <b>Exemption on all vaccines</b> | Indicates the total number of students who have exemptions or no requirements for all vaccines.  |
| <b>In Process</b>                | Indicates the total number of students who have at least one shot that is considered In Process.   |
| <b>No Immunization Records</b>   | Indicates total number of students who have no vaccine records.  |
| <b>Summary Total</b>             | Shows the total count of all previous entries.   |
| <b>Student Count for grade</b>   | Shows the total number of students in each grade.  |
| <b>State Grade</b>               | Displays each grade level in a new row selected when generating the report.  |
| <b>Compliant</b>                 | Indicates the total number of students in a grade level that are compliant or have no requirements for the vaccine.  |
| <b>Medical Exemption</b>         | Indicates the total number of students in a grade with an exemption tied to M: Medical for this vaccine (or one vaccine when all vaccines are selected).   |
| <b>Religious Exemption</b>       | Indicates the total number of students in a grade with an exemption tied to R: Religious for this vaccine (or one vaccine when all vaccines are selected).   |
| <b>Personal Exemption</b>        | Indicates the total number of students in a grade with an exemption tied to C: Personal for this vaccine (or one vaccine when all vaccines are selected).  |
| <b>In Process</b>                | Indicates the total number of students in a grade who have at least one shot that is considered In Process.  |
| <b>McKinney-Vento</b>            | Indicates the total number of students in a grade that have a Homeless status of 3: Physical Custody of Parent/Guardian or 4: Not in Physical Custody of Parent/Guardian on the student's Enrollments tab. |
| <b>Non-Compliant</b>             | Indicates the total number of students in a grade that are non-compliant for this vaccine (or one vaccine when all vaccines are selected).   |
| <b>No Records</b>                | Indicates total number of students in a grade that have no vaccine records.  |
