The KIDS Collection TEST Extract report gathers student data for distributing paper-based state assessments and generating testing rosters for state assessments. The submission window is between the first day of school for the current school in August and the last day of school for the current school year in June.

### **Report Logic**

TEST records are submitted for all students in grade levels mapped to state grade levels of 05-17 (grades KN-12) who are eligible to take state assessments. Students entering a school after February



8 do not have to be tested. One record reports per enrolled student for each selected calendar in the reporting range.

This extract only reports enrollment records that are active within the Reporting Range entered on the Extract Editor (Data Filter From Date, Data Filter To Date). If the Enrollment Start Date or Enrollment End Date fall on the day of the reporting range (Data Filter From Date and Data Filter To Date is the same), the enrollment is included.

Students report regardless of whether they are actively scheduled into course sections.

Students report regardless of whether or not they have any TEST data to report.

One record per enrolled student reports from the selected calendar for the entered Reporting Range.

Students do not report when:

- The Enrollment record is marked as State Exclude or No Show.
- The Calendar of Enrollment is marked as State Exclude.
- The Grade Level of Enrollment is marked as State Exclude.

## **Test Type Selection**

For the TEST extract, select a specific test type or select the option for All Assessment Types to be included. Multiple assessment types can be selected by using the CTRL and SHIFT keys. Assessment Types are assigned on the student's Enrollment record.

When reporting the assessment indicators and assessment, The KIDS Subject reports the disaggregation method based on the reporting end date selected on the Extract Editor or on the Course Schedule Placement end date, whichever comes first. Note the following examples.

- If a student drops section 1, and restarts in section 2 during the reporting range or before course schedule end, disaggregation method reports from section 2.
- If a student remains in the same section, however the reportable teacher changes prior to reporting range or course schedule end, the new teacher reports.
- If a student was not enrolled and/or not scheduled into a course section during the reporting range, a null value reports.

### **Generate the Report**

See the KIDS Collection Extracts editor for description of the Report Editor fields and Sample Report Formats.

- 1. Select the **TEST: Assessment Information Type** from the **Extract Type** dropdown list.
- 2. Enter a Data Filter From Date, if desired.
- 3. Enter a Data Filter To Date, if desired.
- 4. Select the Assessment Disaggregation Method 1 option, if desired.



- 5. Select the Assessment Disaggregation Method 2 option, if desired.
- 6. Mark the **Students without State IDs** checkbox, if desired.
- 7. Mark the Social Security Number Optional, if desired.
- 8. Select an Ad hoc Filter, if desired.
- 9. Select the Grades by State Code option if generating the TEST Extract.
- 10. Select the appropriate **Format** for the extract.
- If generating the extract in the State Format (tab delimited), enter the Records Limit Per File number.
- 12. Select the **Calendars** to include in the extract.
- 13. Select the **Test Types** to include in the extract.
- 14. Click the Generate Report button. The report displays in the selected format.
