By default, enrollment records are listed first by grade level, then by enrollment start date. To reorder the list of enrollments, click the blue hyperlinked headers in the Enrollments Editor list. The list of enrollments can be sorted by Grade, Calendar, Start Date or End Date.

**Enrollment Start Status** indicates the reason a student began enrollment, whether entering the school or district or advancing from another grade. **End Status** indicates the reason a student ended an enrollment, such as leaving the school or moving to another grade.

## General Enrollment Fields

The following table defines each field within the General Enrollment Information editor.

Field	Description
<b>Calendar</b>	The calendar assigned to the enrollment record.
<b>Schedule</b>	The schedule assigned to the enrollment record.
<b>Grade</b>	The student's grade level.
<b>Class Rank Exclude</b>	Excludes the enrollment record from class rank calculations.
<b>Start Date</b>	The start date of the enrollment record.
<b>No Show</b>	Indicates the student was a no show. This field will often exclude the enrollment record from being included in state reports.
<b>End Date</b>	The end date of the enrollment record.
<b>End Action</b>	Indicates whether the student was promoted, demoted or retained following the end of the enrollment record.
<b>Service Type</b>	Indicates the type of enrollment. Options are: <ul style="list-style-type: none"> <li>• P: Primary (default option)</li> <li>• S: Partial</li> <li>• N: Special Ed Services</li> </ul>
<b>Local Start Status</b>	Indicates the reason for starting a new enrollment record.
<b>Local End Status</b>	Indicates the reason for ending the enrollment record.
<b>State Start Status</b>	Displays the state start status mapped to the assigned local start status.
<b>State End Status</b>	Displays the state end status mapped to the assigned local end status.
<b>Transfer to District</b>	Assigned county district code of the district to which the student was transferred.
<b>Transfer to School</b>	Assigned school code of the school to which the student was transferred.

<b>End Comments</b>	Comments about the ending of the enrollment record.


