Health vaccines and their associated compliance listings are based on state guidelines. While Infinite Campus maintains standard guidelines for all states, districts have the ability to enter additional compliances. The following information describes vaccine compliance rules as defined by the Ohio State Department of Health.

General Compliance

- Vaccine doses administered less than or equal to 4 days before the minimum interval or age are counted as valid.
- Doses administered 5 days earlier than the minimum interval or age are not counted as valid.
- Half or reduced doses are not counted as valid.
- If MMR and Varicella vaccines have not been administered on the same day, they must be separated by at least 28 days, with no grace period.
- MMR and Varicella rules are hardcoded. Changes made here will not affect logic.

DTaP

Rule	Requirements
PreK 4 doses Compliant	The student is considered compliant if the following conditions have been met: • the student is in state grade: IN: Infant/Toddler, PS: Preschool, and • the student receives 4 doses of the DT or DTaP vaccine.



Rule	Requirements
5 doses before 48 mos Compliant	The student is considered compliant if the following conditions have been met: • the student receives 5 doses of the DT or DTaP vaccine, and • the difference between the fifth dose and the student's birthdate is less than 47 months with a 4 day tolerance.
4 dose KG-12 Compliant	The student is considered compliant if the following conditions have been met: • the student receives 4 doses of the DT or DTaP vaccine and • the difference between the last dose and the student's birthdate is greater than 48 months with a 4 day tolerance.
3 doses age 7 Compliant	The student is considered compliant if the following conditions have been met: • the student is at least 84 months (7 years) old, • the student receives 3 doses of the DT or DTaP vaccine, and • the difference between the last dose and the student's birthdate is greater than 84 months with a 4 day tolerance.
Default <i>Non-compliant</i>	N/A

Tdap

Rule	Requirements
1 dose Tdap or Td 07-12 Compliant	 The student is considered compliant if the following conditions have been met: the student is in state grade: 07, 08, 09, 10, 11, 12, the student receives 1 dose of the TD, or Tdap vaccine, and the difference between the dose and the student's birthdate is greater than 120 months with a 4 day tolerance.
Default <i>Non- Compliant</i>	The student is considered non-compliant if they are in state grade 07, 08, 09, 10, 11, 12 and have not received any doses of the Td, DTaP, or Tdap vaccine.
Default <i>No Requirement</i>	N/A

Hepatitis B



Rule	Requirements
All Grades Compliant	 The student is considered compliant if the following conditions have been met: the student receives 3 doses of the Hepatitis B vaccine, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the last dose and the second valid dose is greater than 56 fays with a 4 day tolerance, the difference between the last dose and the first valid dose is greater than 112 days with a 4 day tolerance, and the difference between last dose and the student's birthdate is greater than 168 days with a 4 day tolerance.
Default <i>Non- Compliant</i>	N/A

MMR

MMR rules are hardcoded. Changes made here will not affect logic.

Rule	Requirements
1 dose Compliant	The student is considered compliant if they receive one dose of MMR on or after their first birthday.
2 doses Compliant	 The student is considered compliant if the following conditions have been met: the student receives 2 doses of the MMR vaccine, the difference between the first dose and the student's date of birth must be at least 12 months, and the difference between doses 1 and 2 must be at least 28 days.

Varicella

Varicella rules are hardcoded. Changes made here will not affect logic.



Rule	Grades	Additional Requirements
1 Dose Compliant	Childcare, Head Start or Preschool	Dose received on or after 1st birthday.
2 Doses Compliant	Kindergarten	
1 Dose Compliant	1-4 (for the 2010-11 school year. One grade added to requirement each subsequent year.)	Dose received on or after 1st birthday.
No Requirement		All other grades

A 2 Doses Compliant rule will be phased in based on the grades and dates described below:

PreK 3 doses Compliant	The student is considered compliant if the following conditions have been met: • the student is in state grade: IN: Infant/Toddler, PS: Preschool, and • the student receives 3 doses of the IPV, OPV, or IPV/OPV vaccine.
3 doses IPV Compliant	 The student is considered compliant if the following conditions have been met: the student receives 3 doses of the IPV or IPV/OPV vaccine, the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance, and the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance.
3 doses OPV Compliant	 The student is considered compliant if the following conditions have been met: the student receives 3 doses of the OPV or IPV/OPV vaccine, the difference between the third dose and the student's birthdate is greater than 48 months with a 4 day tolerance, and the difference between the third dose and the previous is greater than 6 months with a 4 day tolerance.
4 doses before age 4 Compliant	The student is considered compliant if the following conditions have been met: • the student in state grade 11, 12, and • the student receives 4 doses of the IPV, OPV, or IPV/OPV vaccine.
ages 18 and older No Requirement	Students age 18 (216 months) and older are not required to receive any doses of the IPV, OPV, or IPV/OPV vaccine.
Default <i>Non-compliant</i>	N/A

HIB

Rule	Requirements
1 dose, 15 months Compliant	 The student is considered compliant if the following conditions have been met: the student receives 1 dose of the Hib vaccine, and the difference between the dose and the student's birthdate is greater than 15 months with a 4 day tolerance.



Rule	Requirements
3 doses Compliant	 The student is considered compliant if the following conditions have been met: the student receives 3 doses of the Hib vaccine, and the difference between the last dose and the student's birthdate is greater than 12 months with a 4 day tolerance.
ages 5 and older No Requirement	Students ages 5 (60 months) and older are not required to receive any doses of the Hib vaccine.
Default <i>Non- compliant</i>	N/A

Meningococcal MCV4

Rule	Requirements
Age 16 Booster Compliant	 The student is considered compliant if the following conditions have been met: the student is in state grade: 12, the student receives 2 doses of the Meningococcal vaccine, the difference between the second dose and the previous is greater than 56 days with a 4 day tolerance, and the difference between the last dose and the student's birthdate is greater than 192 months (16 years) with a 4 day tolerance.
Age 16 1 dose Compliant	 The student is considered compliant if the following conditions have been met: the student is in state grade: 07, 08, 09, 10, 12, the student receives 1 dose of the Meningococcal vaccine, and the difference between the last dose and the student's birthdate is greater than 192 months (16 years) with a 4 day tolerance.
Age 11-15 years 1 dose Compliant	The student is considered compliant if the following conditions have been met: • the student is in state grade: 07, 08, 09, 10, 11, and • the student receives 1 dose of the Meningococcal vaccine.
Under 11 No Requirement	Students age 11 in state grade IN: Infant/Toddler, PS: Preschool, KG: Kindergarten, 01, 02, 03, 04, 05, 06, 13: Enrolled, completed course requirements, and 23: Student identified with disability are not required to receive any doses of the Meningococcal vaccine.
Default <i>Non- compliant</i>	Students in state grade: 07, 08, 09, 10, 11, 12, who have not received any doses of the Meningococcal vaccine are considered non-compliant.



Rotavirus

Rule	Requirements
3 doses PK Compliant	 The student is considered compliant if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 3 doses of the Rota vaccine, the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, and the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance.
2 doses PK Compliant	 The student is considered compliant if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 2 doses of the Rota vaccine, the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, and the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance.
1 dose PK In Progress	 The student is considered in progress if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 1 dose of the Rota vaccine, and the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.
Default <i>No Requirement</i>	N/A

Pneumococcal PPV

Rule	Requirements
1 dose PK Compliant	 The student is considered in progress if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 1 dose of the Pnuemococcal vaccine, and the difference between the dose and the student's birthdate is greater than 24 months with a 4 day tolerance.



Rule	Requirements
2 doses PK Compliant	 The student is considered in progress if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 2 doses of the Pnuemococcal vaccine, the difference between the first dose and the student's birthdate is greater than 12 months with a 4 day tolerance, and the difference between the second dose and the previous is greater than 56 days with a 4 day tolerance.
3 doses PK Compliant	 The student is considered in progress if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 3 doses of the Pnuemococcal vaccine, the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, the difference between the first dose and the student's birthdate is less than 11 months with a 4 day tolerance, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, and the difference between the third dose and the previous is greater than 56 days with a 4 day tolerance.
3 doses PK 7-11 Shot Compliant	 The student is considered in progress if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 3 doses of the Pnuemococcal vaccine, the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the third dose and the previous is greater than 56 days with a 4 day tolerance, the difference between the second dose and the student's birthdate is greater than 7 months with a 4 day tolerance, the difference between the second dose and the student's birthdate is less than 11 months with a 4 day tolerance, and the difference between the third dose and the student's birthdate is greater than 12 months with a 4 day tolerance.



Rule	Requirements
4 doses PK Compliant	 The student is considered in progress if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 4 doses of the Pnuemococcal vaccine, the difference between the first dose and the student's birthdate is greater than 42 days with a 4 day tolerance, the difference between the second dose and the previous is greater than 28 days with a 4 day tolerance, the difference between the third dose and the previous is greater than 28 days with a 4 day tolerance, and the difference between the fourth dose and the previous is greater than 56 days with a 4 day tolerance.
1 dose PK In Progress	 The student is considered in progress if the following conditions have been met: the student is in state grade: PS: Preschool, the student receives 1 dose of the Pnuemococcal vaccine, and the difference between the dose and the effective date is less than 28 days with a 0 (zero) day tolerance.
Default PK Non- compliant	Students in state grade: PS: Preschool who haven't received any doses of the Pnuemococcal vaccine are considered non-compliant.
Default <i>No Requirement</i>	N/A
